#### PUBLIC NOTICE

A public hearing will be held by the Mayor and Town Council of the Town of Jonesboro, Louisiana at the City Hall, Jonesboro, Louisiana on September 10, 2019 at 5:30PM at Jonesboro City Hall, 128 Allen Avenue, Jonesboro, La 71251. The purpose of this hearing is to discuss the proposed budget for the Town of Jonesboro, Louisiana for the fiscal year July 1, 2019 through June 30, 2020. The fiscal year budget forecast is to provide \$2,739,875.00 in estimated surplus and revenues to fund a comprehensive array of municipal services anticipated to cost the Town \$2,856,747.00. Prior years unexpended funds will be used to cover expenditures that exceed this year's revenues. The proposed budget is available for public inspection Monday through Friday at the Mayor's office, City Hall, Jonesboro, Louisiana between the hours of 8AM and 4PM. All interested citizens will have the opportunity to give written and oral comments prior to the adoption of the budget. Senior citizens are encouraged to attend and comment.

ORDINANCE: #2019-007

AN ORDINANCE TO ADJUST AND PROVIDE FOR A BUDGET OF REVENUE AND EXPENDITURES FOR THE TOWN OF JONESBORO FOR THE FISCAL YEAR 2019-2020.

SECTION I.

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN of the Town of Jonesboro, Louisiana in regular session on \_\_\_\_\_ that the following budget year 2019-2020, be the same is hereby fixed and established by law.

**SECTION II**

This ordinance shall go into effect immediately upon its adoption and publication.

**SECTION III**

All ordinance or parts of ordinances in conflict herewith are repealed as of the effective date of this ordinance.

**SECTION IV**

BE IT FURTHER ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN, that no official or employee shall be permitted to expend any amount in excess of the said budget as herein established unless the revenue of the said Town shall be received from other sources to provide for the said excess expenditures, and not then unless same shall be submitted to the Mayor and Board of Aldermen for approval.

**SECTION V**

BE IT FINALLY ORDAINED by the Mayor and Board of Aldermen of the Town of Jonesboro that if any item or provision, including and section, exception, part, phrase or term, or the application thereof is held invalid, the application to other persons or circumstances shall not be affected thereby and the validity of this ordinance in any and all other respects shall not be affected thereby. If any phrase, clause, word or other portion of this ordinance is held invalid or to be unconstitutional by any court of competent jurisdiction, the invalidity shall be limited to that portion of the ordinance.
